This letter is in regards to Mr. Bob Bromley's recent response to the GNWT's proposed Greenhouse Gas Strategy. I support Mr. Bromley's efforts to bring serious, engaged reflection into the Legislative Assembly surrounding the topic and welcome his perspective. I understand that his comparison of the Greenhouse Gas Strategy to a "crime against humanity" may seem harsh and undue, but it accurately reflects the real, dangerous and deadly consequences of increasing greenhouse gas emissions, which we are witnessing on a daily basis not only in the Northwest Territories, but globally.

Dear Members of the Legislative Assembly,

I would like to comment on Bob Bromley's recent statement in the Legislative Assembly that the GNWT following through on its existing greenhouse gas (GHG) emission reduction policy would constitute a crime against humanity.

There is no doubt that if climate scientists' truly fearful scenarios about the future actually come to pass, the present lack of sufficient action by most of the world's governments (including the GNWT) to lower GHG emissions will certainly be considered by future generations to have been a crime against humanity.

The NWT GHG Strategy states that "...targets will allow us to demonstrate to the international community we are serious about this issue and prepared to make our contribution to reducing the future impacts of a warming climate." However, the NWT's stated target of 66 percent above 2005 levels (100% above 1990 levels) by 2020 makes even the federal government's underwhelming target of 17% below 2005 levels by 2020 look good by comparison, so surely it will be hard for the international community to believe that the NWT is taking the threat of climate change seriously.

Compare this to Denmark which has set a target of 40% below 1990 levels by 2020! In addition, the Danish government aims to abolish fossil fuel for energy generation by 2035, and by 2050 Denmark is to be completely fossil-free, including the transportation sector.

The GNWT's excuses for its lack of greater action are 1) that the only way to maintain a healthy NWT economy is through increased levels of fossil-fueled non-renewable resource development, and 2) the NWT accounts for less than 0.2 percent of Canada's total annual GHG emissions. The former seems to be set in stone as if there are no alternatives, while the latter is an excuse that any jurisdiction in the world can use to avoid sufficient action.

Northerners are experiencing greater impacts from climate change than anywhere else on Earth, so I find it ironic that, rather than trying to set a good example to the world, the GNWT is taking such a relatively passive, conventional approach to reducing its GHG emissions.

Will future generations judge this government as having been more concerned about its own economic development than the protection of the biosphere on which all Earthly life depends? Will future generations look back on the GNWT as having been involved in a crime against humanity? Time will certainly tell.
