57-19(2) Housing NWT Transfers to Long-term Tenants.

Moved by the Member for Monfwi:

NOW THEREFORE I MOVE, seconded by the honourable Member for Inuvik Twin Lakes, that this Legislative Assembly calls upon Housing NWT to increase

efforts to transfer ownership of Housing NWT units to long-term tenants who have lived in their existing units for 20 years or more and are willing to assume ownership of their family home for a nominal fee;

AND FURTHER, that Housing NWT will work with municipal and Indigenous governments to ensure land leases or fee simple title for their units remains affordable when transferred from Housing NWT to the current tenants.
