SECOND SESSION OF THE NINETEENTH LEGISLATIVE ASSEMBLY

August 28, 2023

The Assembly commenced the hybrid sitting at 1:30 pm, with the Honourable Frederick Blake Jr., Speaker, presiding.

By the order of the Commissioner of the Northwest Territories, the sitting was held outside the capital, in Inuvik. Pursuant to Rule 10.1, the sitting was a hybrid sitting.

Pursuant to Rule 10.1(2), the Speaker allowed the remote participation of the Member for Deh Cho, the Member for Frame Lake, the Member for Great Slave, the Honourable Member for Hay River North, the Member for Hay River South, the Member for Kam Lake, the Member for Monfwi, the Honourable Member for Nahendeh, the Member for Nunakput, the Honourable Member for Range Lake, the Honourable Member for Sahtu, the Member for Thebacha, the Member for Tu Nedhé-Wiilideh, the Honourable Member for Yellowknife Centre, the Member for Yellowknife North, and the Honourable Member for Yellowknife South.

The Speaker advised the House that, pursuant to Rule 10.5(2), special Orders of the Day were issued to ensure the efficient operation of the Chamber, reflecting the Members' desire for a business-focused sitting.

The Speaker advised the House that he had received the following letter from the Commissioner, the Honourable Margaret Thom:

Dear Mr. Speaker: I wish to advise that I recommend to the Legislative Assembly of the Northwest Territories the passage of *Appropriation Act (Infrastructure Expenditures), 2024-2025*; and *Supplementary Appropriation Act (Operations Expenditures), No. 2, 2023-2024*, during the second session of the 19th Assembly.

Further, the Speaker advised that, pursuant to Rule 3.5(1), the Member for Monfwi wished to move a motion for emergency debate, calling upon the Government of the Northwest Territories to ensure that Indigenous Governments are involved in the Government of the Northwest Territories' response to end the wildfire emergency. Typically, a Member would move the motion for an emergency debate at the conclusion of oral questions; however, the special Orders of the Day did not include Oral Questions. Pursuant to Rule 10.5(2), and in an effort to balance the privileges of the Member and the Assembly, the Speaker directed that the motion for emergency debate be considered after Third Reading of Bills.
