



### Remediation Economy – Background


- The Northwest Territories (NWT) has over 500 sites that are anticipated to require assessment, remediation and/or long-term monitoring activities.
- A Strategic Partnership Initiative (SPI) was identified to ensure Indigenous communities, NWT residents and businesses benefit from the Remediation Economy.

### Remediation Economy – Background

- Over the next 30 years, estimated remediation expenditures of more than \$4.8B are expected in the NWT.
  - Remediation will support as many as 700 Full-Time Equivalent (FTE) positions per year for approximately 15 years.
  - Annual spend is anticipated to be around \$291M per year over the next 15 years, generating approximately \$151M in GDP for the NWT annually in that timeframe.

• Most of the economic activity will be in the North Slave Region.

## Anticipated NWT Labour/Training Needs

- Many of the labour market needs of remediation mirror those of the mining and infrastructure sectors
  - Associated services or labour categories are varied, but can include:
    - o environmental sciences (engineers, technicians, hydrologists)
    - o heavy equipment operation (drilling, excavation, labourers), and
    - $\circ$   $\;$  administrative and project management support
- About 40% of the estimated labour needs will require postsecondary education or training.

# What is the Strategic Partnership Initiative (SPI) program?

- SPI was identified as a funding opportunity for Remediation Economy training and labour market preparedness programming.
- Launched in 2010, Indigenous Services Canada's SPI program works to increase Indigenous participation in large, complex, multi-year economic opportunities that span a range of sectors.
- Since 2010, more than 400 Indigenous communities have benefitted either directly or indirectly.
- 223 partnerships have been created from SPI investments.

## **GNWT and Government of Canada Collaboration**

- CIRNAC (NWT Region), CanNor and the GNWT have worked to advance the concept of a 'Remediation Economy' since 2021. (Four phase collaboration)
  - Phase 1 involved the analysis of economic opportunities associated with contaminated site assessment, remediation and monitoring
    - o Opportunity Profile (CIRNAC)
    - Discussion Paper (GNWT)
  - Phase 2 involved further analysis of economic opportunities and a full application to SPI, which was approved
    - Made in the North Action Plan (CIRNAC)
    - Further analysis and Engagement including Have Your Say online survey (GNWT)
  - Phase 3 (Current Phase): Coordination and Funding Applications
    - $\circ$  Creation of GNWT-Government of Canada Remediation Coordination Committee (RCC)
  - Phase 4: Implementation and Progression

### **GNWT Involvement – Remediation Economy**

- 3 GNWT Depts involved in Remediation Economy and SPI
  ITI: GNWT lead on Remediation Economy file
  - **ECE:** Labour force capacity building and training lead
  - ENR: GNWT lead on Giant Mine Remediation Project (GMRP)
  - Remediation Coordination Committee includes representation from ITI, ECE and ENR at ADM level.

# Current SPI Activity – Coordination and Funding Applications

- SPI Phase 3 Initiatives underway
  - Skills Development
    - North Slave Regional Training Partnership: ECE developing a proposal for SPI funds to reform this partnership
    - Skills Development Programs: Aurora College is planning two training programs based on SPI funding
  - Business Capacity Development
    - CIRNAC Contractor (Catalyste+) applied for SPI funding to support the enhancement of Indigenous participation in major Remediation opportunities.

## **ECE: Supporting Remediation Economy**

- North Slave Regional Training Partnership
  - Coordination of training initiatives
  - North Slave Regional Training Hub
- Regional Operations
  - Labour Market Program supports

## Skills Development Programs – Aurora College

- Aurora College is seeking to use SPI funding, based on the Remediation opportunities action plan, to address the skills development gaps of Remediation projects.
  - Northern Technical Program: For such fields as Project Management Technician, Safety Technician and/or Quality Assurance/Quality Control Technician
  - Northern Remediation Monitoring Program: Environmental monitoring field that is specifically designed for remediation and reclamation sites.

## Enhanced Business Capacity – CIRNAC Contractor

- Catalyste+ (contractor) will be brought on to:
  - Engage with Indigenous leadership (Tłįchǫ, Yellowknives Dene First Nation, and Sahtu communities, and members of the North Slave Metis Alliance)
  - Match staff from Indigenous Economic Development Corporations with Catalyste+ Advisors
  - Connect Indigenous participants to other regional supports available.
- Catalyste+ Advisors will develop tailored mentorship plans

## Giant Mine Remediation Project - ENR

- Giant Mine Remediation Project is co-managed by the GOC (CIRNAC) and the GNWT (ENR)
- Parsons, the Main Construction Manager for GMRP, is responsible for the majority of hiring and contracting associated with the GMRP.
- Remediation Activities began in the summer of 2021
- 2022-2023 saw an overhaul in project design and increased estimated costs for GMRP
  - Implementation of remediation work has been extended to 2038
  - Updated cost estimate of \$4.38B

### Remediation Economy – Next Steps

- Continued collaboration between GNWT and GOC to collaborate on Remediation Economy file, including formation of Remediation Coordination Committee (RCC)
  - RCC to meet monthly, and then quarterly, to advance Remediation Economy initiatives
  - RCC to create a 5-year "roadmap" (updating original action plan) to ensure a collective understanding on timelines, deliverables, and key performance indicators.
- Review of applications and funding provided to successful applications
- Coordinated implementation of initiatives and programs
