NORTHWEST TERRITORIES EMERGENCY PLAN MODERNIZATION

I am here today to brief Committee members on a newly modernized Northwest Territories emergency management plan and framework.

With me from MACA are Eleanor Young, Deputy Minister; Ivan Russell, Manager, Emergency Measures, Kevin Brezinski, Director of Public Safety, Melissa Kruger, Senior Policy and Legislative Advisor; and my Ministerial Special Advisor, Mira Dunn.

A short presentation has been provided to help describe the new emergency management plan and framework, and the path which has led us to these documents.

As you know, revitalizing the NWT Emergency Plan is a priority for the 18th Legislative Assembly.

Climate change and recent emergency events have highlighted a real need to improve the GNWT's approach to emergency management.

Working closely with all GNWT departments, these instruments represent lessons learned from previous events, and best practices from across Canada. They provide the structure and guidelines on how the GNWT and its partners work together to support community governments and meet a collective responsibility in responding to territorial emergencies.

I wish to acknowledge the contributions of staff from all GNWT departments who contributed significantly to the development of these important documents, and the preparations which are now taking place to put these instruments into practice.




What is the NWT Emergency Plan?

- Created and administered by MACA under the authority of the Emergency Measures Act. Last updated in 2001;
- Describes the emergency management framework in the NWT, and the roles and responsibilities of departments and partners during emergencies;
- Includes.
- A description of the NWT emergency management system;
- A framework for relationships with other departments, governments and preparing for and responding agencies in emergencies; and non-government
- GNWT procedures for the coordination of responses to territorial emergencies and in supporting communities during disasters.



NWT Emergency Plan Activations



Progress to Date

- NWT Hazard Identification Risk Assessment (2014);
- Public discussion Modernizing the Civil Emergency Measures Act (2014);
- Comprehensive After Action Review 2014 Wildfires (2015);
- Legislative Proposal Emergency Management Act (2015);
- Established an interdepartmental committee to update the NWT Emergency Plan (2015 2017);
- Researched relevant best practise across Canada;
- Validated departmental roles and responsibilities in support of civil emergency response (relative to HIRA);
- 0 Developed a new regional and headquarters delivery model based on the Incident Command System (ICS);
- Created a new NWT Emergency Management Framework;
- Updated the NWT Emergency Plan;
- Created guidelines for community evacuations;
- Updated the Emergency Communications protocol;
- Developed an executive communications plan;
- Developed an implementation strategy; and
- Started formal ICS training with assistance from the Alberta Emergency Measures Agency.
- Drafting of a bill underway for the new Emergency Management Act (2017-2018)



Why are we modernizing the plan?

- Political and public expectations across the NWT and Canada are evolving.



What's New

- Incident Command System
- In use by emergency management partners across the NWT (e.g. ENR, RCMP, JTFN, federal partners, etc.)
- Offers a standardized organizational structure, functions processes, and terminology.
- Standardized processes allow all involved in a response to formulate a unified plan to manage the incident
- Standardized ICS plain language terminology reduces the risk of miscommunication.
- aspects that are necessary for a given incident The system is scalable, which allows officials to use only those
- Training is readily available.

Surge Capacity

- GNWT personnel capable of supplementing resources at the periods of intense or prolonged activity; territorial and regional Emergency Operation Centres (EOC) during
- Most events may be managed by MACA personnel;
- Additional contingent desired ten (10) in HQ and six (6) in regional centres (to ensure sufficient availability);
- Roles involve communications, logistics, planning and operations;
- exercises ICS/EOC training provided and maintained via table-top or live
- Volunteers approved by Deputy Ministers;
- immediate supervisor; Participation in operations and training activity must be approved by



Subject Matter Experts

- emergency planning and response efforts relative to Pre-identified GNWT positions capable of informing responsibilities specified in the NT Emergency Plan; prevalent hazards and departmental roles and
- Access to departmental resources and approval authorities
- If and when required;
- Basic ICS training provided;
- Ministers; Identified by NWT EMO and approved by Deputy



NWT Emergency Planning Committee

- Coordinate and lead emergency management planning for the GNWT;
- Provide advice to the Emergency Management Organization;
- Develop and maintain the Territorial Emergency Plan; and
- Carry out testing of the Territorial **Emergency Plan**
