Oral Question 574-18(3): Mental Health Services Wait Times

This letter is in follow up to the Oral Question you raised on February 20, 2019 regarding Mental Health Wait Times.

Community Counselling Programs (CCP) are located in all regions and provide free counselling for mental health, addictions and family violence, as well as referrals to other resources including things like facility based addictions treatment.

Some CCP within larger centers have wait times for non-urgent clients ranging from approximately 1 week in Fort Smith to 35 weeks in Hay River. Smaller communities generally do not experience wait times for non-urgent services.

Clients are triaged to ensure those who require urgent counselling are seen with same day appointments. Clients who are eligible may also be referred to Employee and Family Assistance Programs or Health Canada Programs. Short-term workshops and groups may also be offered to accommodate some clients on the wait list.

On The Land Programs is another option for residents. The Department of Health and Social Services provides funding to regional and community Indigenous governments to support community designed, culturally relevant land based healing programs. These programs are not intended to replace counselling or to reduce counselling wait times, rather they provide another option residents may choose regarding their own personal healing and recovery needs.

In 2018-19 a total of eight Contribution Agreements have been signed with seven regional Indigenous governments and one community Indigenous government. The agreements have supported 35 distinct On The Land Healing activities/programs in 23 different communities as listed below:
