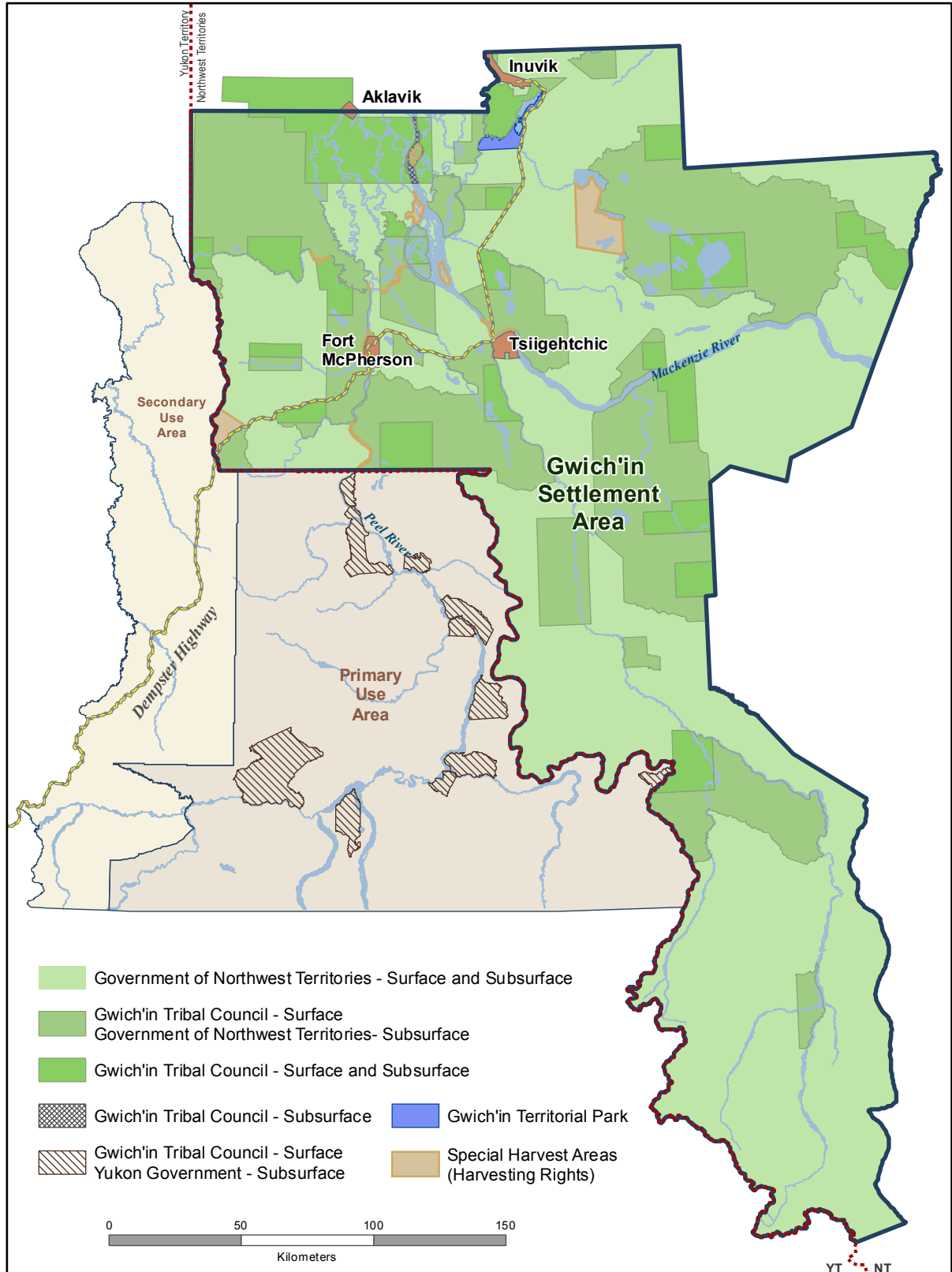

# CHAPTER 1: BACKGROUND AND OVERVIEW

## DINEHTŁ'EH 1: GWICHIH TS'AT GWITOH TTHAK GWIZHIT GOO'AI

### 1.1 BACKGROUND

On April 22, 1992, the Gwich'in Tribal Council (GTC) and the Government of Canada (Canada) signed the Gwich'in Comprehensive Land Claim Agreement (GCLCA), and the accompanying Implementation Plan (IP). The GCLCA came into effect on December 22, 1992. The Government of the Northwest Territories (GNWT) is a committed partner in the implementation of the GCLCA and is responsible for a number of implementation activities.

The GCLCA provides certainty regarding the ownership, use, and management of lands and resources. Through the GCLCA, the Gwich'in received title to 22,329 square kilometers of surface land and 6,158 square kilometers of subsurface lands in the Gwich'in Settlement Area (GSA) of the Northwest Territories (NWT), and 1,554 square kilometers of surface land in Yukon.

The GCLCA promotes the Gwich'in way of life which is based on Gwich'in culture and traditional relationship to land, and supports Gwich'in economic development and self-sufficiency. The GCLCA allows for the protection and conservation of wildlife and environment within the settlement area for present and future generations. The GCLCA also provides for the negotiation of self-government agreements which could be brought into effect through federal or territorial legislation, or both.

Other major provisions of the GCLCA include:

- Gwich'in wildlife harvesting rights and right of first refusal for commercial wildlife activities.
- The establishment of institutions of public government to co-manage wildlife, and regulate land, water and the environment.
- Guaranteed nominated membership for the Gwich'in in institutions of public government created pursuant to the GCLCA.
- Gwich'in receipt of \$75 million, in 1990 constant dollars, in tax-free capital transfers, which was paid out over 15 years and amounted to \$141 million.

### 1.1 GWICHIH

Jii GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltssaii) fi'aa nan eenjit gwits'at k'agwaaadhat giniint'arii, t'atr'ahdahch'aa, ts'at nan k'adagwidaadhat eenjit ts'at nihli'ejuuk goonlii. Jii GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltssaii) guuk'iighe', jii Gwich'in kat nan gwits'at k'agugwaaadhat 22,329 t'agwahnjuu nan kak guuthinjik ts'at 6,158 t'agwahnjuu nan kak gwizhit Gwich'in Nan Diits'an Nilii Gwinaguu'ee (GSA) Nanh Gwiniink'oo (NWT) eenjit, ts'at 1,554 t'agwahnjuu nan kak Yukon gwizhit.

Jii GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltssaii) gwiiyeendoo gwits'at tr'iinjii jii Gwich'in nits'oo gugwindaii jidii Gwich'in yeenoo nits'oo tr'igwiindai' ts'at nan hah ndoo tr'igwee'aa, ts'at Gwich'in gwits'at tr'iinjii ts'at khanigaandaii. Jii GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltssaii) ihtoo t'igwiheenjaa ch'ii' ts'at nan k'andehganahtii kat jii nin dachan gwiit gwa'an ts'at diinagoo'ee gwizhit nan diits'an nilii juuk ts'at yeendoo ji' nihli'daazhii kat guuveenjit. Jii GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltssaii) aii ts'at geenjit ginjih gidaaghoo jii kheenjit k'adagwidaadhat Łagwiinaadhan duulee gwik'it goonlii jii iisrits'at adachoo nat goo dinjii kat eenjit k'adagwidaadhat vadatr'igwijiilcheii dagwidji'e', goo neekaii ts'at.

Jii GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltssaii) Ezhii gwiinchii leii gwizhit go'arii:

- Gwich'in nin dachan gwiit gwits'at tr'oonjih dagwidji'e' ts'at dagwidji'e' akwaa tr'oochit gwichih gwidineht'eh nihlehnehch'i' ts'at gwitr'it nihlehnehch'i' eenjit.
- Jii fi' hah inihlik gwizheh choo tthak geenjit chit nihkhaa nin dachan gwiit, ts'at nan guk'andehganahtii, chuu ts'at gwinagoo'ee eenjit.
- Łqphah Gwich'in uuzri' tr'oonjik gwizhit go'arii eenjit inihlik gwizheh choo tthak geenjit dagwidji'e' GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltssaii) geenjit tr'igwii'tsaii.

## 1.2 OVERVIEW OF THE GCLCA PROVISIONS

- **Eligibility and Enrolment:** The Enrolment Board was established to enrol those who are entitled to be registered as Participants of the GCLCA. The Enrolment Board is comprised of five people appointed by the GTC, including one from each of the four Gwich'in communities. The board is responsible for processing applications for Gwich'in enrolment into the GCLCA, maintaining an Enrolment Register, and publishing the Enrolment Register annually. Currently, the GTC's Board of Directors serves as the de facto Enrolment Board. Therefore, enrolment remains an ongoing responsibility of the GTC's Board of Directors.
- **Self-Government:** The GCLCA provides for the negotiation of self-government agreements. Self-Government agreements can be brought into effect through territorial and federal legislation. Self-Government agreements cannot contradict or be inconsistent with the GCLCA (as amended from time to time), nor can they affect the Gwich'in right to participate in any constitutional development of the NWT. These agreements will address the desire of the Gwich'in to have self-government exercised as close to the community level as is reasonably possible.
- **Dispute Resolution:** The Gwich'in Arbitration Panel (GAP) was established to resolve disputes in accordance with the GCLCA. The GAP is comprised of eight members, four of which are nominated by the GTC and two by the GNWT and Canada respectively.<sup>1</sup>
- **Designated Gwich'in Organizations:** Designated Gwich'in Organizations (DGOs) are committed to executing the responsibilities of the Gwich'in outlined in the GCLCA. A DGO must be a trust, society, or corporation established pursuant to federal or territorial legislation. All rights exercisable by a DGO- such as receiving and managing financial payments and owning and managing land- were assigned by the GTC prior to the signing of the GCLCA. The GTC is responsible for maintaining a public record of DGOs and their duties.

## 1.2 JII GCLCA TTHAK GWIZHIT GWITS'AT TR'IINJII

- **Duulee gwizhit diinch'uu ts'at Oozri' tr'adant'oo:** Jii Oozri' tr'adant'oo Iisrits'at jilch'einat tr'igwitsaii jii juudin kat Oozri' guunjih GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltisaii) gwizhit Diiyàh t'igidi'ii eenjit. Jii Oozri' tr'adant'oo Iisrits'at jilch'einat ihloogwinli' gwizhit giinlii GTC (Gwich'in Dinjii Zhuh Eenjit Jilch'einat) goovoozri' ezhik niginiinli', Gwich'in kaiik'it daan kat gwits'at gwi'ihlee. Jii Iisrits'at jilch'einat Gwich'in oozri' tr'adant'oo gwidineht'eh geenjit guugwitr'it go'aii jii GCLCA gwizhit, Oozri' tr'adant'oo Gwidineht'eh k'aganhdak, ts'at publishing nagwidadhat ihtak khaii gwizhit ts'at khaii inihlik. Jùk, jii GTC's Iisrits'at jilch'einat guk'anhdak giinlii jii gwits'aii geenjit guudii. Aii eenjit, oozri' tr'adant'oo gwidineht'eh nihk'it shik guk'andehganahtyàh jii GTC's Iisrits'at Jilch'einat.
- **Kheenjit-Adachoo:** Jii GCLCA agidành geenjit ginjih gidaaghooh kheenjit-adachoo łagwiinaadhan eenjit. Kheenjit-Adachoo łagwiinaadhan dinjii kat eenjit k'adagwidaadhat ts'at Iisrits'at adachoo nat agidành duulee dągwidjje' guguwahtsaii. Kheenjit-Adachoo łagwiinaadhan duuyeh jii GCLCA (geetak ejuk tr'ahtsaii) gwits'agwikhaa t'igiheech'aa kwaa guuvah shik nihk'it gwiteelyaa chan, duuyeh edjuk nits'oo jii Gwich'in gwidagwidjje' gwizhit Iisrits'at dągwidjje' gwitr'it gwahahtsah NWT geenjit. Jii łagwiinaadhan leii gwik'ighe' gwits'at tr'igjikhii jii Gwich'in kat kheenjit-adachoo giiniidhan, khe' guukaiik'it gwizhit gòo nyahgwan gwits'at gi'gwidhan ts'at.

# CHAPTER 1: BACKGROUND AND OVERVIEW

## DINEHTŁ'EH 1: GWICHIH TS'AT GWITOH TTHAK GWIZHIT GOO'AI

- **Financial Compensation:** Under the provisions of the GCLCA, Canada paid approximately \$141 million over 15 years to the GTC as the organization representing Gwich'in Participants. The GTC commenced the repayment of the negotiation loans in 1993. Canada subtracted the loan repayment costs from the capital transfer payments.<sup>2</sup>
- **Resource Royalties:** Through the GCLCA it was established that the government must pay a percentage of the royalties received from resource development projects operating in the Mackenzie Valley to the GTC. The GTC was identified as the recipient for the royalties in Chapter 9 of the GCLCA. Payments are made to the GTC on a quarterly basis.
- **Economic Measures:** The economic measures chapter of the GCLCA requires that Government (Canada and the GNWT) economic development programs in the GSA take into account the following objectives:
  - o The traditional Gwich'in economy should be maintained and strengthened; and
  - o The Gwich'in should be economically self-sufficient.

- **Nihti'edjuk òokat Gwitsèedhòh:** Jii GCLCA kat chit kat gugwitr'it gwits'at tsèedhòh/lazhaa lat niht'ejùk òokat gwitsèedhòh guuheetat jii niht'ejùk gwitr'it ndòò hàh figweedhaa Nàgwichoon-jik Gwinagòò'ee gwizhit GTC gwits'at. Jii GTC agadanh tr'iginah'ii tsèedhòh/lazhaa jii niht'edjuk òokat gwitsèedhòh guuheendal t'agwidàadhat gwats'at tseedhòh diits'an tr'ahtsih Dineht'eh 9 gwizhit jii GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltssaii) kat. - **Gwitr'it Gwitseedhoh K'atr'inahtih:** Jii gwitr'it gwitseedhoh K'atr'inahtih gwidineht'eh jii GCLCA (Gwich'in Nan Eenjit Łagwiinaadhan Gwiltssaii) eenjit akòò digwiheech'aa jii Adachoo (Canada ts'at GNWT) gwitr'it gwitsèedhòh k'atr'inahtih ndòò figweedhaa jii GSA jidii akòò dagwiheedy'aa gwiiniidhan gwizhit:
  - o Jii Gwich'in gwitr'it ndòò tr'igwee'aa k'atr'inahtih ts'at gwheenet'aii; ts'at
  - o Jii Gwich'in kheenjit-gwitr'it zhangwiteelyaa.

Government must also consult with the GTC regarding any new economic development programs that relate to these objectives and meet with the GTC every three years to discuss the effectiveness of such programs.

When it comes to government contracting in the GSA, Canada must follow its contracting procedures to maximize local and regional employment business opportunities and the GNWT must follow its contracting procedures to maximize local, regional and northern employment and business opportunities in the GSA.

- **Wildlife Harvesting and Management:** Chapter 12 of the GCLCA sets out the extensive wildlife harvesting rights of the Gwich'in in the GSA and provides for the establishment of the Gwich'in Renewable Resources Board (GRRB). It is the responsibility of the Board, in collaboration with the other parties, to protect, conserve, and manage, in a sustainable manner, renewable resources within the GSA, and to meet the needs of the public today and in the future.<sup>3</sup>
- **Land and Water Regulation:** Chapter 24 of the GCLCA provides for the creation of the following implementing bodies pursuant to legislation:
  - o The Gwich'in Land and Water Board (GLWB) regulates land and water use throughout the GSA.<sup>4</sup>
  - o The Gwich'in Land Use Planning Board (GLUPB) is tasked with developing a land use plan for the GSA, and with reviewing and proposing amendments to the plan.<sup>5</sup>
  - o The Mackenzie Valley Environmental Impact Review Board (MVEIRB) is mandated to conduct environmental impact assessments of development proposals within the Mackenzie Valley. The GCLCA provides for Gwich'in-nominated membership on the Board, the ability of the GTC to refer development proposals to the MVEIRB that may impact the GSA, as well as an opportunity for the GTC to nominate members to Review Board panels, which are established from time to time.<sup>6</sup>

# CHAPTER 2: GWICH'IN IMPLEMENTATION COMMITTEE

## DINEHTŁ'EH 2: GWITR'IT GAH IISRITS'AT GWIK'IT T'IGIDI'IH IISRITS'AT JILCH'EINAT

Section 28.2 of the GCLCA calls for the establishment of the Implementation Committee (IC). It is the responsibility of the IC to oversee and provide guidance regarding the implementation of the GCLCA. The IC is responsible for monitoring the status of the various activities outlined in the Implementation Plan (IP) and may revise the schedule of activities, reallocate resources and amend the IP as required. Furthermore, the IC is responsible for mitigating any issues that arise between parties regarding the implementation of the GCLCA. The IC also produces a report annually documenting the implementation of the GCLCA.

The IC is comprised of one member from the GTC, the GNWT and Canada. The following section provides a brief description about the parties to the IC.

### 2.1 GTC

The GTC is the organization mandated by the GCLCA to represent the Gwich'in Participants. It was established in 1992 and it is mandated to protect and preserve the rights and interests of the Gwich'in. In addition to their work through the IC, they also work to promote, preserve and enhance Gwich'in customs, culture, traditional values, language and develop social, educational and economic programs.<sup>7</sup>

During the 2018-2020 fiscal years, the GTC was represented on the IC by Mr. Jordan Peterson, Deputy Grand Chief of the GTC. In 2021, Grand Chief Ken Kyikavichik represented the GTC.

### 2.2 GNWT

The Department of Executive and Indigenous Affairs (EIA) is responsible for coordinating the GNWT's implementation activities under the GCLCA. The GNWT was represented on the IC by Susan Bowie, Director, Implementation Division, EIA, from 2018 to 2020 and by Sahara Morin who assumed the position during the 2020/21 fiscal year.<sup>8</sup>

Jii IC gwizhit guugwitr'it, gwits'aii chan gwiiyeendoo gwitr'it gwiinzii gwits'an gahtsih, k'atr'inahtih ts'at Gwich'in yeenoo nits'oo tr'igwiindai', diinigwinj'ee, gwik'iindigwizhit ndòo tr'igwee'aa, yeenoo nits'oo tr'igwiindai' gwit'ajahch'uu, diiginjik ts'at datthak ndòo figweedhaa, ge'tr'oonahant ts'at nihli'ejuk gwitr'it gwaatsii.<sup>7</sup>

## 2.3 CANADA

Canada is represented on the IC by the Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC). It is the mandate of CIRNAC to renew Nation-to-Nation relationships, assist Indigenous people in capacity building, support Indigenous people's vision of self-determination and advance reconciliation.<sup>9</sup>

CIRNAC's Implementation Sector is responsible for monitoring and facilitating the fulfillment of the federal government's obligations as outlined in the GCLCA and the Implementation Plan (IP). The Implementation Sector provides funding to the implementing bodies: the GTC and the GNWT, as identified in the IP.

During the 2018/19 fiscal year, Canada's representative on the IC was Mr. Dale Pegg, Director, Treaty Management West, Implementation Sector. During 2019/20 fiscal year, Monica van Huystee, Acting Director, Treaty Management West represented Canada at the IC and then later that year, Patrick Barthold assumed the position of Director, Treaty Management West.

## 2.3 CANADA

# CHAPTER 3: REPORT ON ACTIVITIES FOR THE FISCAL YEARS 2018/19, 2019/20 TO 2020/21

## DINEHTŁ'EH 3: NIHLINEHCH'I' TS'ÀT GWITR'IT T'AGWAA'II FOR THE KHAI GWIZHIT GEENJIT GWITSÈEDHÒH GWI'DINEHTŁ'EH 2018/19, 2019/20 GWITS'AT 2020/21

This chapter provides an overview of the key items discussed by the IC during the 2018/19, 2019/20 to 2020/21 fiscal years. This chapter is divided into three sections: highlights, issues addressed and projects undertaken.

### 3.1 HIGHLIGHTS

#### GWICH'IN INTERNSHIP PILOT PROJECT

The Gwich'in Internship Pilot Project (GIPP) is an initiative proposed by the GTC and implemented by the parties to strengthen the GTC's institutional capacity and promote participation of the Gwich'in in the Northern economy and workforce. The project was designed by the GTC to enhance the skills and work experience of Gwich'in Participants in government operations through on-the-job training. The project represents a coordinated effort by the GTC, Canada and the GNWT to provide practical work experience that will lead to a greater understanding of the public sector and prepare interns for future career opportunities, potentially within the GTC.

Each Gwich'in Participant admitted to the program served three consecutive one-year work placements, one with each level of government. As host organizations, the GTC, Canada and the GNWT placed interns in areas that reflected their individual interests and specific career aspirations. Placements were enhanced with formal and informal learning and mentoring opportunities.

During the May 2018 IC meeting, the GTC expressed its interest to advance the project to the next stage. The GNWT proposed that the program could have a more focused approach and address the skill gaps the GTC would like to address and build around self-government implementation. However, Canada outlined the challenges associated with the project which included:

- delays in finding federal placement;
- challenges with relocation; and
- time required to complete Canada's security screening process.

In order to mitigate the problems in implementing GIPP, Canada proposed a new approach.

Work is underway to determine an extension of the GIPP. This would involve the Gwich'in as well as other groups. The GNWT is also exploring a program similar to GIPP, with the aim of facilitating secondments and building capacity.

## GWICH'IN ACADEMIC CONFERENCES

In an effort to encourage and support Gwich'in youth to pursue post-secondary education, the GTC developed a series of Academic Conferences to expose students to the post-secondary education environment. By taking Gwich'in students from small communities and introducing them to the world of academic study and campus life, the GTC's goal has been to increase the number of Gwich'in youth pursuing post-secondary studies.

To date, a series of five academic conferences have been held at universities across the country supported by funding from Canada:

- March 23 – 27, 2015 – Memorial University, St. Johns, Newfoundland: 10 Gwich'in youth participated in the GTC's inaugural academic conference.
- March 7 – 11, 2016 – Carleton University, Ottawa, Ontario: 14 Gwich'in youth participated in the conference.
- March 27 – 31, 2017- Inuvik, Northwest Territories: Circumstances did not permit travel to a university; however, a successful conference was held in Inuvik for 22 Gwich'in youth.
- March 9 – 13, 2018 – University of Alberta, Edmonton, Alberta: 15 Gwich'in youth participated in the conference.
- May 6-10, 2019 – University of Saskatchewan, Saskatoon, Saskatchewan: 10 Gwich'in Youth participated in the conference.

The success of the program has been unprecedented, with 89% of youth attendees going on to full time post-secondary studies, internships and full-time employment.

## TREATY 11 CENTENARY CELEBRATIONS

Treaty 11 is the last of the numbered treaties signed between the Crown and representatives of the Dehcho, Tłı̨chǫ, Sahtu and Gwich'in (formerly Loucheux) peoples in 1921. The historic treaty was the foundation of the subsequent GCLCA, in which provision 3.1.11 obligates the parties to annually recognize the historical and cultural importance of Treaty 11, in addition to treaty annuity payments made by Canada.

The summer of 2021 marked the 100th anniversary of the signing of Treaty 11. The CIRNAC regional office led the planning for centenary commemorations across the Northwest Territories, which began work in 2018 but was delayed by the COVID-19 pandemic.

# CHAPTER 3: REPORT ON ACTIVITIES FOR THE FISCAL YEARS 2018/19, 2019/20 TO 2020/21

### 3.2 ISSUES

#### ANNUAL REPORT

The GCLCA requires the Implementation Committee to prepare an annual report on the implementation of the GCLCA. Canada is responsible for publishing the reports. However, in the past, the GNWT agreed to undertake the drafting and preparation of the reports on behalf of Canada.

In the fiscal year 2019/20, the GNWT completed the consolidated annual report for the fiscal years of 2015/16, 2016/17 and 2017/18. The report was published in French, English and, for the first time in Gwich'in.

Canada has resumed its responsibility for producing annual reports. In order to ensure consistency and to streamline the production of annual reports, Canada created a template for the annual report which was used to draft the consolidated 2018-2021 report.

#### CONSOLIDATED VERSION OF THE GCLCA

Several amendments have been made to the GCLCA since it came into effect in 1992, however, these amendments were not consolidated into a revised version. Therefore, in 2015, the GTC took the responsibility for consolidating all the amendments into an updated version of the GCLCA. The GTC, the GNWT and Canada have been working collaboratively in reviewing the consolidated version to identify inaccuracies and/or inconsistencies.

In April 2018, the GTC shared the updated consolidated version of the GCLCA based on the GNWT's and Canada's comments; following which both the GNWT and Canada provided the GTC with final comments. Representatives from all parties met after the December 2019 IC meeting to review and finalize the consolidated version of the amendments. Similar work needs to be done to create the French consolidated version of the GCLCA. The English and French consolidated versions of the GCLCA were finalized in 2021. The next step is to ensure concurrence of all parties regarding the final consolidated English and French versions of the GCLCA. Following the concurrence, Canada will post the consolidated version on the Government of Canada website.

## AMENDMENT ON LAND EXCHANGES

In September 2016, the GNWT proposed an amendment to the GCLCA that will address and clarify the status of lands which are subject to land exchanges. Through this amendment, any land received by the GTC from Canada or the GNWT pursuant to a land exchange will be recognized and treated as settlement land. To date, there have not been any land exchanges under the GCLCA.

The proposed amendment raised concerns regarding tax implications. Canada reached out to Finance Canada to seek further direction regarding tax implications associated with the GNWT's proposal. A representative from Finance Canada participated in the discussion regarding the amendment on land exchanges and concluded that advancing with the proposed amendment will require approval from the Minister of Finance. However, before proceeding, Finance Canada required clarification from the GTC and the GNWT in regard to the proposed land exchange amendment.

The GNWT has already responded to Finance Canada's queries. Following the receipt of the GTC's response, Finance Canada will proceed to request approval from the Minister. This would allow the parties to proceed with the amendment which includes drafting a record of decision confirming that the IC supports the amendment.

## ECONOMIC MEASURES

According to the Economic Measures chapter (Chapter 10) of the GCLCA, government is required to meet with the Gwich'in at least once every three years to review the effectiveness of the programs related to the objectives outlined in chapter ten. To advance the review, at the May 2018 IC meeting the GNWT tabled the *Economic Measures Monitoring and Review Framework* along with the methodology for consideration. The GNWT also tabled a Terms of Reference for an Economic Measures review project.

Work on the review was halted for some time as the GTC indicated in both the December 2018 and February 2019 IC meetings that they would not be able to participate in advancing the project at the time due to capacity issues. Work restarted after the February 2021 IC meeting following the election of new GTC leadership in September 2020. In March 2021, the parties signed a Terms of Reference to conduct the Economic Measures review and have convened a tripartite Economic Measures Working Review Group to advance the review.

## DINEHTŁ'EH 3: NIHLINEHCH'I' TS'ÀT GWITR'IT T'AGWAA'II FOR THE KHAI GWIZHIT GEENJIT GWITSÈEDHÒH GWI'DINEHTŁ'EH 2018/19, 2019/20 GWITS'AT 2020/21

### BOARD APPOINTMENTS

At the October 2019 IC meeting, Canada communicated with all parties that they are working on streamlining the board appointment process to make it more efficient along with reviewing board honoraria. A working group was established as a part of the Recognition of Indigenous Rights and Self-Determination (RIRSD) discussion to work on streamlining the board appointment process. Canada shared a review of the board appointment process with the relevant boards and parties in 2020 and is currently exploring the possibility of using a Ministerial appointment process rather than an Order-in-Council.

Furthermore, the GTC proposed that in cases of vacancy, the parties should coordinate a year in advance to reduce delays in the appointment process. It was also suggested that using common terminologies for the appointment process may be helpful to facilitate the tracking of board appointments in the system.

### CLEANUP OF CONTAMINATED SITES

There are forty-one (41) abandoned oil and gas wells and other contaminated sites in the GSR. These sites were left behind by industries undertaking mining and oil and gas development in the GSR, which pose the risk of leaking hazardous materials into the surrounding environment.

The issue of contaminated waste sites was raised by the GTC during the 2018 IC meeting, when the GTC communicated a desire to have them identified in the Yukon primary and secondary use areas of the GSR. In October 2020, the GTC submitted a proposal to inspect abandoned oil and gas wells in the Northwest Territories as well. Funding from the Climate Change Preparedness in the North Program was secured in February 2021 to gather baseline data and prepare a report with recommendations for this initiative.

### 3.3 PROJECTS

#### IP RENEWAL

The previous 10-year implementation plan expired in 2013. Several factors, including reduced federal capacity and changing leadership of the GTC contributed to the delays in the IP renewal process. However, the parties have completed their internal review of the draft IP and are now developing draft consultation activity sheets. The parties await completion of the Amendments to the Dispute Resolution Chapter of the GCLCA (described below) to complete the IP. Once the draft IP is approved by the parties, the IC can proceed with a Record of Decision and the federal Order-in-Council process.

#### AMENDMENT OF THE DISPUTE RESOLUTION CHAPTER OF THE GCLCA

In 2018, the Gwich'in requested a Recognition of Indigenous Rights and Self Determination (RIRSD) table. One of the issues raised at the table was amending Chapter 6 of the GCLCA, the dispute resolution chapter. The Gwich'in want to move away from an arbitration panel detailed in the GCLCA to a staged approach since it fosters relationships, could result in faster resolution of issues, and may be less costly when there are disputes amongst the parties. Other Indigenous groups in the Northwest Territories have recently adopted this approach. The Gwich'in also requested consideration of traditional Gwich'in dispute resolution mechanisms to be included in the staged approach. A working group of the parties to the GCLCA was struck in early 2019 and work on a revised dispute resolution model and chapter was substantively concluded in 2020. The GTC proposed to develop procedural guidelines detailing the different staged approaches to dispute resolution and how to apply them in case of dispute. The IC awaits GTC's development of procedural guidelines to complete the project, which would allow finalizing the IP.

### GWICH'IN LAND SURVEY

The comprehensive land survey of the GSA was never completed and certain parcels in the NWT remain un-surveyed. During the October 2019 IC meeting, Canada confirmed that the Yukon parcels were surveyed in the mid-1990s. Natural Resources Canada (NRCan) has agreed to complete the survey and has provided the IC with a proposal to define the boundaries of the GSA using the method of Isolated Boundary Standard. All the work regarding land surveys will be conducted under the Surveyor General Branch.

After work was delayed due to the COVID-19 pandemic, Canada communicated to all parties during the February 2021 IC that NRCan secured a mandate for surveying activities in the Northwest Territories, to begin in April. The survey program is funded for five years and is slated to conclude in fiscal year 2025/26. The first year would focus on mapping watershed boundaries, the second through fourth years on the outstanding 52 parcels in the GSA, and the final year on any remaining tasks.

### AKLAVIK LAND EXCHANGE

An engineering firm recently reassessed the solid waste site (SWS) in Aklavik as having 10-20 years of remaining life span. The hamlet entered into discussions with Municipal and Community Affairs (MACA) of the GNWT regarding the possibility of a land exchange for Gwich'in settlement land outside of the community for a new SWS. The land exchange proposal also included an access road to access a gravel source outside the community.

At the October 2019 IC meeting the GTC stated that they have engaged in discussions with the municipality, Ehdiiat Gwich'in Council, Inuvialuit Regional Corporation (IRC), and GLWB but, the GTC indicated that their Lands and Resources Department had not received an application for a land exchange from the municipality (Hamlet of Aklavik), and unless such an application is received by the GTC it cannot act accordingly.

## PLACE NAMES

In 2015, the GTC Department of Culture & Heritage (DCH) completed a project to develop an inventory of Gwich'in place names in the Gwich'in Settlement Region, titled "Gwich'in Goonanh'kak Googwandak: The places and names of the Gwich'in." Four-hundred and fourteen (414) of these place names were formally recognized by the GNWT and sixty (60) by the YG as of November 2020.

In 2019, the GTC expressed an interest in acquiring the ability to rename places within the GSA without approval from the GNWT, as is currently required under section 25.1.12 of the GCLCA. Work on a proposal to amend the aforementioned provision for this purpose is underway at the IC.

## YUKON TRANSBOUNDARY ISSUES

During the period covered by this report, the parties began meeting in Whitehorse once a year to facilitate face-to-face meetings with the YG on Gwich'in Transboundary issues. Only two such meetings were held before in-person meetings were postponed due to the COVID-19 pandemic.

## GOVERNMENT OF YUKON – GTC COMMUNICATION PROTOCOL

Following the Yukon Northern Affairs Program Devolution Transfer agreement, the communication protocol was established to facilitate meetings between senior officials of the YG and the GTC. The GTC has expressed interest in expanding the protocol to include other Gwich'in organizations and the Teet'it Gwich'in Band Council in Fort McPherson; this interest was acknowledged by the YG.

During the October 2019 IC meeting, the GTC communicated to the YG that they see consultation as an essential component of the communication protocol. The YG acknowledged this and proposed to engage in further discussion with the GTC to advance an expanded communication protocol.

### *PEEL WATERSHED LAND USE PLAN UPDATE*

The Peel Watershed is an area in the Yukon that includes the GTC's Yukon land and is a pristine wilderness area that is important for traditional First Nation harvesting and cultural activities.

In August 2018, YG formed a Senior Liaison Committee (SLC) to manage the process regarding the Peel Watershed Land Use Plan (PWLUP). In the SLC, the GTC was represented with status similar to the Yukon First Nations. The GTC expressed their satisfaction regarding the collaborative approach taken to address issues concerning the PWLUP as well as the recognition of the Gwich'in as a Yukon First Nation and hoped to see the same process used as a model for acknowledging and respecting Gwich'in rights in the Yukon. The next challenge will be the implementation phase of the PWLUP.

### *PROPOSED VUNTUT GWITCHIN LAND EXCHANGE*

When the Vuntut Gwitchin Final Agreement was signed in 1995, four parcels of land were found to be outside of the agreed upon envelope during the survey which was completed after the agreement was signed. These four parcels are within the Vuntut Gwitchin Traditional Territory that overlaps the Tetlit Gwich'in Secondary Use Area. The errors were identified within a year of the signing of the Vuntut Gwitchin Final Agreement.

Discussion regarding the land exchange occurred between Canada, the GTC, the YG and the Vuntut Gwitchin First Nation (VGFN). The GTC discussed the issue during their 2019 Annual General Assembly and the General Assembly reaffirmed that the discussion regarding the land exchange should be done at the community level in consultation with the GTC. Furthermore, the GTC asked that representatives from the YG and Canada meet with the representatives of the four Gwich'in communities and listen to their concerns regarding the land exchange. On February 4, 2020, a meeting was organized in Fort McPherson between the YG, the GTC, VGFN and Canada, with Canada providing funds for the meeting. In April 2020, VGFN sent a follow-up letter to the GTC with next steps to proceed with the land exchange.

Canada, GTC kat, YG kat, ts'at Vuntut Gwitchin First Nation (VGFN) kat jii nan nihjeh gwits'an tr'ahtsih (land exchange) geenjit ginjih tr'idaagho'. GTC kat jii gwit'agwij'ee geenjit tr'igjikhè' 2019 Annual General Assembly ts'at jiii General Assembly chan geenjit tr'igjikhè' jii nan nihjeh gwits'an tr'ahtsih (land exchange) diikaiik'it danh geenjit ginjih gadaagho' tr'ahàhtsaa giiniidhan jii GTC guuvah. # CHAPTER 4: REPORT ON IMPLEMENTATION FUNDING FOR THE FISCAL YEARS 2018/19, 2019/20 AND 2020/21

## DINEHTŁ'EH 4: GWITR'IT IISRITS'AT GWIK'IT T'IGIDI'IH GWITSÈEDHÒH/LAZHAA GEENJIT JII KHAII 2018/19, 2019/20 TS'ÀT 2020/21 GWIDINEHTŁ'ÈE'

In addition to its regular implementation funding of \$760,301.00 from Canada for the 2018/19 FY, in March 2019, the GTC received \$479,968.50 to support various activities related to the Yukon Transboundary Agreement. For the 2019/20 fiscal year, the GTC received \$770,102.00 in implementation funding and \$500,000.00 for Yukon Transboundary activities. From 2020/2021, the GTC received \$786,935.00 and \$500,000.00 respectively. During the same fiscal year, the GTC also received a total of \$2,685,392.00 in funding to address emergency needs related to the COVID-19 pandemic.

In regard to Implementation Funding, at the December 2019 IC meeting Canada's funding officer provided a short presentation on the templates and reporting requirements for annual work plans, interim reports and final reports. The templates provide guidance regarding the information Canada requires for reporting in order to provide implementation funding.

During this meeting, the GTC communicated that the GTC's Department of Culture & Heritage requires funding for on-going cultural heritage activities and projects and for multi-year programs on cultural heritage research. Canada said they will consider the request and discuss it further internally. Canada also communicated its intentions to include Yukon Transboundary Agreement (YTA) implementation funding in the GCLCA funding renewal going forward, in order to provide secure funding for the 10-year life of the funding arrangements.
